Narrative Detail

On 10-07-15 LEI Schwab conducted a sworn and recorded interview with [REDACTED]. The following is a summary of the interview:

[REDACTED] said [REDACTED] was referred to Dr. Schneider by one of the Dentists at Regency Dental, because [REDACTED] and would not stop resisting the Dentist while he was working on [REDACTED]. The Dentist advised [REDACTED] that [REDACTED] needed to be sedated for the procedure and Dr. Schneider is the dentist in the area that does pediatric [REDACTED] and takes Medicaid.

[REDACTED] said [REDACTED] called Medicaid to ascertain if Dr. Schneider took Medicaid. When [REDACTED] called Dr. Schneider's office [REDACTED] was able to get an appointment for the following day for an examination. According to Dr. Schneider's records [REDACTED] [REDACTED] said they did the examination and Dr. Schneider said that [REDACTED] and a visit was scheduled for the next day. Dr. Schneider told [REDACTED] [REDACTED].

[REDACTED] said [REDACTED] brought [REDACTED] to Dr. Schneider's office for the next visit and [REDACTED] was given a

██████████. They had to wait about thirty minutes, then Dr. Schneider began working on ██████████. As Dr. Schneider was ██████████ said that ██████████ was trying to comfort ██████████ and asking Dr. Schneider if he thought that ██████████ could feel the pain. ██████████ said that Dr. Schneider was rough and emotionless about ██████████'s comfort level. ██████████ said ██████████ was screaming and crying and ██████████ again asked Dr. Schneider about ██████████, ██████████ was told by Dr. Schneider ██████████. According to Dr. Schneider's records ██████████. While ██████████ was checking out ██████████ was told there were ██████████. ██████████ said ██████████ told the receptionist that it would have to wait about a month, because ██████████ wanted to give ██████████ some time to get over what happened.

██████████ said the third visit to Dr. Schneider was similar to the previous visit. When Dr. Schneider started working on ██████████'s teeth ██████████ started crying and screaming. ██████████ said that she asked Dr. Schneider if ██████████ could feel the pain, this time Dr. Schneider told her ██████████ stated that there no way ██████████ was leaving. Dr. Schneider performed ██████████. As ██████████ was checking out ██████████ was advised that ██████████ needed something else done, and they made ██████████ an appointment in a month.

██████████ advised that ██████████ did not keep that appointment because ██████████ felt like there were always more issues (the office was adding) but ██████████ could not see ██████████ and ██████████ did not complain ██████████. ██████████ said one of the ██████████ after a week and ██████████ had to go back to have it ██████████. ██████████ also said that the other ██████████ also. ██████████ said that ██████████ refuses to take ██████████ back to Dr. Schneider. ██████████ also stated that the ██████████ that Dr. Schneider used were so big that ██████████.
