clothing and was pacing in a dark area. Upon seeing my marked unit the defendant began to walk away. I then made contact with the defendant and asked him what he was doing there and he advised that he just got dropped off by a friend and he was waiting to be picked up by another friend to go to his house and hang out. I asked the defendant if he had any identification and he advised that he had left his ID at home. The defendant gave me his name and date of birth verbally which I positively identified him through DAVID. The defendant was arrested for loitering and prowling and was transported to Davie PD where he was left in the care of BSO detention deputies.
