Before me the undersigned Fourth Circuit Judicial Officer, in and for Duval County; notary public; or law enforcement officer personally came **B E BARNES**, who, being duly sworn deposes and says that he/she has reason to believe and does believe that one **Sion Khadeem Henry**, described as follows: Last known address: **7344 Fox Grove Road, Jacksonville, FL 32244**; Race: **Black**; Sex: **Male**; DOB: **11/24/1990**; Ht: **5' 09**; Wt: **155**; Hair: **Black**; Eyes: **Brown**, Scars, Marks: ; did in Duval County, Florida, on February 19, 2016, commit the below-listed offense(s), contrary to the provisions of Florida Statutes:

- 1) 794.011(4)(b), SEXUAL BATTERY; F1
- 2) 812.13(2)(C), ROBBERY; F2

Affiant's reasons for so believing are as follows:

Your affiant is a Detective assigned to the Special Assault Unit of the Jacksonville Sheriff's Office with over nine years of police experience.

Your affiant spoke to the victim, [REDACTED] on 2-19-16. She stated that on 02-19-16, between 1740 and 1800 hrs., she was walking home from shopping at the Publix grocery store located at 13820 Old St. Augustine Rd (Duval County Florida). The victim was pushing her infant child in a stroller. As the victim approached a courtyard area in the middle of the shopping center the suspect, **Sion Khadeem Henry**, approached the victim and attempted to engage the victim in conversation. The victim ignored the suspect and proceeded out a gate toward the rear of the shopping center. The victim crossed the roadway behind the shopping center and got onto a grassy path which served as a shortcut to her residence. The suspect, who had driven around the shopping center, parked and got out of his car. The suspect caught up to the victim on foot. The suspect pushed the victim away from her child's stroller and then grabbed the stroller with his hand. He threatened to push the stroller with the child in it into a retention pond next to the pathway, unless the victim had sex with him. The victim initially cooperated with the suspect out of fear for her child's safety. The suspect pushed the victim downhill from the path into a wooded area and onto an old mattress which was laying on the ground, where he forced penile/vaginal sex on the victim and also digitally penetrated her vagina. The suspect attempted to force penile/anal sex on the victim, but she started fighting. The suspect stood up and forcibly took the victim's wallet with her identification in it, as well as her cellular telephone. The suspect left the scene in an unknown direction.

The victim received a medical examination at the Sexual Assault Forensic Examination facility later that night. The sexual assault kit collected during the examination was turned in to the JSO property room and subsequently taken to the Florida Department of Law Enforcement for analysis.

On 02-25-16, your affiant received information that laboratory analysis by FDLE revealed the presence of a DNA profile foreign to the victim on vaginal swabs collected in the sexual assault kit. The foreign DNA profile found in the sexual assault kit matched the listed suspect, **Sion Henry**.

On 02-25-16 at 1400 hrs., your affiant presented a photograph of the suspect, **Sion Henry** to the victim, in order to determine whether or not the suspect was a previous consensual sexual partner. Upon viewing the photograph, the victim immediately became visibly upset. She pointed to the picture and said, "That's him." She went on to clarify that the photograph was of the suspect who sexually battered her on 02-19-16. The victim signed and dated the photograph. She then began crying and ran to her mother in another room.

At all relevant times the suspect was over the age of 18.


