IT IS ORDERED that the defendant be permitted the following:

- (1) The defendant is hereby fully exonerated of any and all charges or penalties, including supervised released/ probation; originating from the Federal, State, Traffic, and Civil courts. Any and all records pertaining to charges; whether they are case, evidence, or arrest are to be expunged and made nonexistent to any record. All warrants and bonds are to be cancelled and resented. In the instance of any monetary bonds, it is also ordered that all bonding agencies who received payment from the defendant and/or defendant's family are to provide full reimbursement of funds to the defendant and/or defendant's family no later than 2- 5 business days upon the receiving of this order.

- (2) Current or otherwise pending charges against the defendant originating from the Florida state Felony, Misdemeanor, traffic, or civil courts of the following counties: Duval, Clay, Volusia, and all other inner or surrounding counties of Florida are hereby ordered to drop and dismiss all charges and penalties; which also includes warrants, bonds, and the expungement and making nonexistent to any record case, evidence, or arrest records pertaining to charges. Also including traffic offences, traffic citations, and points. Furthermore, the State is to provide disposition notification of said offenses addressed on behalf of the defendant as verification that order has been carried out and actions has been completely processed through Florida States Clerk of court and submitted to the Federal Clerk of court and the defendant immediately upon the hour of receiving this order.

- (3) It is hereby ordered to the Department Of Motor Vehicle to resend, drop, erase, or otherwise expunge any and all traffic violations, citations, points, revocations, suspensions, cancelations, fees, and penalties; from any State, Province, City, County, or Town. Reset and restore to perfect driving record, with full driving privileges the defendant Aaron Marcus Richardson, Date of Birth 01/08/1989, SSN# 591-19-1666, DL# R263013890080. Also the defendant is to be allowed to reinstate and renew driver license and vehicle registration without the assessment of a fee or charge for the completion of these actions upon presenting this order to any DMV branch or participating Tax collection agency. Order is to be carried out immediately upon the hour of receiving this order; verification of actions completed is also to be provided to the Federal Clerk of Court and the defendant.
- (4) It is ordered to all creditors, credit reporting agencies, debt collection agencies, businesses, loan providers, institutions, banks/ credit unions, schools, colleges, and universities; to cancel, drop, and erase from any record all credit blemishes, debts, negative accounts/ balances, payments due, late payments. Fines, fees and penalties. Reset and restore to complete financial grace and stability the defendant Aaron Marcus Richardson/ Birth date 01/08/1989, SSN# 591-19-1666, DL# R263013890080; finances, assets, accounts, and transactions. This order is also documentation verifying that the defendant is not the cause of the above stated financial/ credit issues, this order is to be carried out immediately upon the hour of receiving the order. Documentation must be provided to the defendant verifying the completion of ordered actions in same allotted time frame.

Additional Information

These orders are granted by the power of the **UNITED STATES DISTRICT COURT MIDDLE DISTRICT OF FLORIDA JACKSONVILLE DIVISION**. Based on the grounds that it has been concluded after a thorough investigation that the defendant in fact did not commit said offenses convicted of or otherwise and was the victim of identity theft actually dating back since the year 2003 to current, which resulted in certain individuals of no association the defendant utilizing the defendants identity and personal information to commit these crimes stated and a plethora of other illegal actions. It was also discovered in this investigation that at the time of the committing of these crimes the defendant was not only no within the state of Florida but was impaired physically and in the emergency room of a North Carolina Hospital. Any other information pertaining to the above stated is confidential and

not to be questioned. It is not permitted that the defendants personal and biographical information be viewed, requested, submitted or otherwise made available for official or public use. The defendant is to no longer be reprimanded nor held accountable for these crimes/ charges; and is to be fully granted the full United States civil rights and privileges of a prominent citizen from this day forth. Furthermore it is also ordered neither that myself _____ nor any other Judge, court, whether it is Federal, State, Traffic, or Civil, and law enforcement cannot and will not overturn, alter, be in compliant to, ignore or otherwise overstep these orders.
