Non-Compliance Description

04-01 A ratio of [1] staff for [6] children is required. There were [1] staff for [a mixed age group of 13 children: 3 one year olds and 10 school age] children observed.

Comments

While conducting an inspection of the rooms, 10 school age children were moved from the VPK room, which included 5 children found hiding in the closet, into the one year old's room where 3 one-year-olds were located. These additional 10 children with the 3 one-year-old children brought the ratio out of compliance, as 3 staff members were required for this mixed age group. Ratio in this room was corrected at approximately 3:45 PM, when parents began picking up their children, and the children were reshuffled to different rooms to meet the staff to child ratios.

Please provide a plan of action to meet the staff to child ratio for early release days.

05-01 Direct supervision of children in the [school age] group was inadequate in that [during the facility's inspection, 5 of the 10 school age children were discovered by counselor hiding in the closet without any adult's supervision].

Comments

Once the children were found in the closet, counselor brought them to the front room where the director was located. The director did not deny the fact that the children were hidden there to conceal them from the capacity count.

05-07 A child was not adequately supervised and left the facility premises without the knowledge or awareness of staff.

A 6 year old child escaped from the facility without the knowledge of the staff members. The child was later found by the JSO and brought back to the center.

Non-Compliance Description

19-06 The facility did not have the required usable floor space available per child in the [one-year-old's room that contained 13 children, instead of 10; the infant room had 7 babies instead of 6, and also had 24 children present instead of 23 children in the VPK] room/area.

Comments

The violation in both rooms was corrected when parents began picking up their children at approximately 3:45 PM, which resulted in having 3 children in the one-year-olds room and 19 children in the VPK room.

Technical assistance regarding room capacity in the 2 infant rooms was also provided. The director was given a copy of the floor plan that contained each room's capacity for immediate posting to eliminate any confusion in the future.

Please provide a plan of corrective action to meet the school age children's accommodation on early release days that will not compromise the rooms capacity.

Correction was completed after the nap was over, and some of the parents began picking up their children. Counselor advised the director of the room capacity, and the fact that stored mats in the corner of this room took away the available space for children to nap on. Hence, alternative storage space for the mats is recommended.

Child was missing for approximately thirty minutes.
