

On April 13, 2016, pursuant to a criminal investigation conducted by the Jacksonville Sheriff's Office Integrity / Special Investigations Unit (ISIU), an arrest warrant (CCR #2016-0233237 / S.A. #16-AF-021319) was signed by Fourth Judicial Circuit Court Judge John I. Guy (Duval County), for the arrest of Jacksonville Sheriff's Office Police Officer Adam R. Boyd #7766 for the crimes of Official Misconduct (a third degree felony), Grand Theft (a third degree felony), and Petit Theft (a first degree misdemeanor). On April 14, 2016, ISIU arrested Boyd and he was booked into the Pre-Trial Detention Facility (PDF). Also, on April 14, 2016, Internal Affairs initiated an administrative investigation based on the allegations of misconduct leading to Boyd's arrest.

Accordingly, Internal Affairs reviewed the following pertinent information:

 Jacksonville Sheriff's Office General Offense Report (CCR #2016-238000) and subsequent Supplement Report #1. The following information was contained in the supplement report (verbatim), authored by ISIU Detective

On 01-21-2016, Detectives and interviewed two known prostitutes regarding an unrelated Human Trafficking investigation. During their interview of the detectives were told was having sex with a Jacksonville Sheriff's Office police officer. Indenied she had sex with officer but advised she knew the officer as "Andy". Explained has had sex with "Andy" several times in exchange for "information." further advised "Andy" wanted to have sex with her, but she refused.

On 01-21-2016, Detectives and conducted an interview of at the Integrity Unit office regarding the information of her having sex with an officer. admitted she has had sex with the officer she knows as "Andy" on several occasions. described the officer as a white male, about 41-42 years old, short dark hair and said she knew the officer had gone to law school. advised she did not know his real name but advised the officer wrote a police report at her home a few years ago. advised she has sex with the officer on a consensual basis and denied receiving any "information" or money from the officer in exchange for sex. advised the officer would bring her cigarettes or food or give her money if she asked but not in exchange for sex.

I researched address and located a police report written by Officer Adam Boyd description provided by Detectives and Showed \*\* REDAMINS THIS PAGE: FSSIIS.071(4)(c), [19.071(2)(f.)

a picture of Boyd and immediately identified Boyd as being the officer she had consensual sex with.

On 01-26-2016, Detective received a call from who advised she needed to provide information on a police officer who was having sex with prostitutes. It told that she lived with advised an officer had been having sex with in exchange for money. If further advised the same officer sexually battered her on two separate occasions. If advised she moved to and had heard detectives recently interviewed the information she knew. If advised a detective would respond to to speak with her regarding her allegation.

On 01-27-2016 at 0930 hours: Detective and I conducted an interview of regarding the information had provided to Detective

advised she lived in Jacksonville with a roommate named from 2012 to 2014. She advised they lived at While living at this address, advised a police officer would visit for the purpose of having sex. It recalled the first time she witnessed the officer having sex with was possibly in May of 2012.

advised on that day in 2012, asked her to grab a condom and come outside. advised she exited the residence and went into the detached garage. When she entered the garage, the phenoms this Phase: ISS [19.07] (4)(c), [19.07](2)(f.), [19.07](2)(h.)].

and a uniformed police officer were standing in the garage. gave the condom because advised she was going to "trick" with the police officer. Prior to exiting the garage, stated the officer advised he would look out for them to make sure no one investigated them with their "Back Page stuff".

advised the police officer would have sex with once a month for approximately one year. She stated the officer would pay \$10 each time. Stated as time went on, the officer became more comfortable because he normally parked down the street but eventually started parking his marked police car in the driveway. She advised the officer was in uniform each time he came to the residence.

did not know the police officer's name or car number but provided the following description: white male, 5'9" to 5' 11", not over weight, clean cut with dark hair parted to one side.

further stated and went to jail in 2013 for bad checks. She stated received 4 months jail time and received 6 months jail time. It stated during this timeframe is when she was sexually battered by the same police officer.

advised a friend of hers called and was coming over to her residence. She advised there was a knock at her door a short time later, so she opened the door assuming it was her friend. Upon opening the door, observed the \* CEDACTIONS THIS PAGE: FSS 119.071(2)(h) 1., 119.071(2)(f.)

same officer had been having sex with standing in the doorway.

advised the officer was in uniform and walked into the residence.

advised once the officer entered the residence, the officer saw her cell phone on the table. advised the officer went over to the cell phone and made sure it was turned off. advised the officer then grabbed her arm while standing near the couch and pulled her towards the back bedroom. advised she told the officer about her friend coming by at which time the officer stated "he won't stop because of my police car." stated he then opened a dresser drawer which contained two crack pipes and condoms. The officer then made the comment he has the ability to look out for them and to keep the police away from the residence.

advised the officer then placed her on the bed and pulled out his penis which was already erect. advised the officer performed penile/vaginal intercourse on her for approximately 4 minutes. advised the officer did not get undressed and only pulled his pants down. advised she was lying on the bed and he was in a standing position. She stated the officer wore a condom and flushed it down the toilet after the incident.

because he was a police officer. She advised if it was anyone other than a police officer, she would have tried to fight or stab him but she felt as if she could not resist because he was an officer.

told her he saw a police car when he came by so he did not stop.

then told what happened and he asked if she was ok.

then came by the residence to check on

advised the only other time she had sexual contact with the officer was approximately one month later. Stated there was a knock on the door so she opened it to find the officer. She advised the officer was in uniform and entered the residence and checked her cell phone again. Stated he then led her back to the bedroom and had penile/vaginal sex with her. She stated once again this was not consensual and she never accepted any money from the officer. Advised the details of the sexual assault were not as clear as the first encounter because she was high.

\*Note: advised she felt she would be arrested on both occasions if she did not allow the sex to occur. She further added that she did not resist either time because he was an armed police officer.

advised she moved out of residence in 2014. She advised she moved to an address on and had the electricity in her own name. She advised after she moved, she started to receive phone calls from a blocked number. advised she initially answered the phone until she discovered it was the officer. She advised the officer was attempting to locate her. advised she stopped answering the calls and had not spoken with the officer since then.

advised her phone service was with Verizon at the time and the account was in her name. She thought the cell phone number was but advised it could have been another number from Verizon under the same account which she could not recall from her memory.

We inquired who knew about the officer or the incident. advised she told and and and and and and all the sheet. Fss II9.071(2)(h.)1., II9.071(2)(f.)

advised she has had no contact with the officer and has not been back to Jacksonville since.

Detective and I showed a photo spread containing a photograph of Officer Adam Boyd and five filler photographs. Prior to showing the photo spread, we had her read the JSO photo spread instructions form (P-1306) at which time she acknowledged she understood them both verbally and by signing her name. Upon viewing the photographs, immediately selected Boyd from the group as the subject in question.



I spoke with Kathleen Jones from Verizon regarding the subpoenas sent to them. They cannot provide call detail records beyond 1 year. The request was for call details between

Boyd was arrested as a result of a separate investigation (CCR 16-233237).

On 04-15-2016, I presented this case to Assistant State Attorney R.

Mantei who agreed that probable cause does exist to arrest Boyd for

sexual battery. However, due to the likelihood of not receiving a conviction, Mantei advised his office would not issue an arrest warrant and would not seek prosecution. Mantei cited a lack of physical evidence and/or additional witnesses as concerns for filing that charge against Boyd.

Case is exceptionally cleared.

#### SYNOPSIS

On 01-21-2016, an unrelated criminal investigation was initiated involving Officer Adam Boyd #7766 During that investigation, which is still ongoing, it was learned that Officer Boyd was working secondary employment at various apartment communities/ shopping centers. It was discovered that Officer Boyd was not present at those sites for the same amount of time he reported he was working at those sites.

02-13-2016: Boyd reported he worked secondary employment for Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1430-1830 hours (4 hours). Boyd arrived at the site late at approximately 1648 hours and left the site early at approximately 1805 hours. Boyd reported he was present at the site for 4 hours but was actually only present for 1.25 hours. Also, Boyd submitted an overtime request (Comp time) for 1730-1830 hours (while working secondary employment). Boyd's reason for the overtime was "Pull crime stats for 145."

02-22-2016: Boyd reported he worked secondary employment for Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1430-1830 hours (4 hours). Boyd arrived at the site late at approximately 1447 hours and left the site early at approximately 1701 hours. Boyd reported he was present for 4 hours but was actually only present for approximately 2.25 hours.

02-26-2016: Boyd reported he worked secondary employment for Southgate Plaza (JSO permit #1222-4) located at 3490 Beach Blvd. from 1300-1800 hours (5 hours). Demetree Brothers is the company that pays for this job. Boyd arrived at the site at approximately 1254 hours and left the site at approximately 1714 hours. Boyd reported he was present for 5 hours but was actually only present for approximately 4.33 hours. Also on this date, Boyd reported he worked secondary employment at Demetree Brothers (Sabal Palms Apartments- JSO permit #1222-0) located at 2150 Emerson Street from 1800-2300 hours (5 hours). Boyd arrived at that site at approximately 1757 hours. Boyd left that site at approximately 2235

hours. Boyd reported he was present for 5 hours but was actually only present for approximately 4.61 hours.

Boyd arrived at the site 1 hour late at approximately 1900 hours. Boyd's vehicle left the site at approximately 0145 hours (02-28-2016). Boyd reported he was present for 8 hours but was actually only present for approximately 6.75 hours.



Boyd reported he was present at the site for 5 hours but was actually only present for approximately 3.25 hours. Later this day, Boyd reported he worked secondary employment at Demetree Bros. Cleveland Arms Apartments (JSO permit #1222-2) located at 5020 Cleveland Rd. from 1600-2100 hours (5 hours). Boyd arrived at the site late at approximately 1651 hours and left the site at approximately 2042 hours. 03-11-2016: Boyd reported he worked secondary employment at Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1430-1830 hours (4 hours). Boyd arrived late at approximately 1630 hours and left the site early at approximately 1755 hours. Boyd reported he was present at the site for 4 hours but was actually only present for approximately 1.42 hours.

03-12-2016: Boyd reported he worked secondary employment at Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1430-1830 hours (4 hours). Boyd arrived late at approximately 1613 hours and left the site early at approximately 1805 hours. Boyd reported he was present at the site for 4 hours but was actually only present for approximately 1.75 hours.



03-14-2016: Boyd worked as PIC for his squad. Boyd's regular working hours are 1830-0555 hours. At 1830 hours, Boyd's vehicle was still at his residence and did not leave until approximately 2040 hours. The vehicle traveled straight to Commonwealth where it remained the rest of the night. Records show Boyd's vehicle was brought into Commonwealth for AC problems and the transmission was slipping. Boyd picked up his vehicle from Commonwealth on 03-21-16 at approximately 1952 hours.

Boyd reported he was present at the site for 4 hours but was actually only present for approximately 1.5 hours. Also on this day, Boyd reported he worked secondary employment at Demetree Bros Cleveland Arms Apartments (5020 Cleveland Rd., JSO Permit #1222-2) from 1830-2330 hours (5 hours). Boyd arrived at the site at approximately 1830 hours and departed the site early at approximately 2251 hours. Boyd reported he was present at the site for 5 hours but was actually only present for approximately 4.33 hours.

Vestcor Fund XVI Ltd. d/b/a Lindsey Terrace Apartments (JSO permit #3193-0) located at 6455 Argyle Forest Blvd. from 1700-2100 hours (4 hours). Boyd arrived in the area of the site at approximately 1655 hours but parked in the parking lot of the closed business located at 6155 Youngerman Circle(formerly Circuit City), which is across the street from Lindsey Terrace Apartments. Boyd parked on the northwest corner of the parking lot near Interstate 295. At approximately 1817 hours, Boyd traveled to the parking lot of the shopping center located at 6001 Argyle Forest Blvd. At 1847 hours, Boyd returned to the same spot in the parking lot of the closed business where he stayed until approximately 2059 hours. Boyd then left the area. Boyd's vehicle did not enter Lindsey Terrace Apartments at all during the hours he reported he was present there. Also, Boyd did not log out on any calls for service at the closed business or the shopping center.

O3-25-2016: Boyd reported he worked secondary employment at Demetree Enterprises, LLP (shopping center located at 4368 University Blvd S., JSO Permit # 1027-0) from 1500-1900 hours (4 hours). Boyd arrived late at the site at approximately 1540 hours. Boyd left the site at approximately 1849 hours. Boyd reported he was present at the site for 4 hours but was actually only present approximately 3.16 hours. Also on this date, Boyd reported he worked secondary employment at Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1900-2300 hours (4 hours). Boyd arrived at the site late at approximately 1935 hours and left the site early at approximately 2213 hours. Boyd arrived at the site at approximately 1926 hours. Boyd then left the site at approximately 0050 hours (04-01-16). Boyd

drove to the area of the PMB for approximately 1 hour and then to the area of Church and Julia Streets for a few moments. Boyd departed that area at approximately 0233 hours and returned home. Boyd did not go back to Queen's Harbour after leaving around 0050 hours. Boyd did not log out on any calls for service during his absence from the site. Boyd reported he was present at the site for 7 hours but was actually on present for approximately 5.33 hours.

04-01-2016: Boyd reported he worked secondary employment at Vestcor Fund XXII (Gregory Cove Apartments- JSO Permit #3399-0) located at 5601 Edenfield Rd. from 1300-1700 hours (4 hours). Boyd arrived at the site late at approximately 1448 hours and departed the site early at approximately 1602 hours. Boyd reported he was present at the site for 4 hours but was actually only present for approximately 1.16 hours. Also on this date, Boyd reported he worked secondary employment at Spyglass Apartments (JSO permit #5300-1) located at 8540 Homeplace Dr. from 2200-0300 hours (5 hours). Boyd arrived at the site at approximately 2215 hours and departed the site early at approximately 0215 hours. Boyd reported he was present at the site for 5 hours but was actually only present for approximately 4 hours.

04-02-2016: Boyd reported he worked secondary employment at Vestcor Fund XVI Ltd. d/b/a Lindsey Terrace Apartments (JSO permit #3193-0) located at 6455 Argyle Forest Blvd. from 1430-1830 hours (4 hours). Boyd did not work at Lindsey Terrace Apartments on this day. Instead, Boyd arrived at Gregory Cove Apartments (Vestcor Fund XXII) at approximately 1453 hours and departed there at approximately 1824 hours. Boyd was present at those apartments for approximately 3.5 hours.



04-05-2016/0845 hours:

is the assigned scheduler for off duty officers at the various locations owned by Demetree (Cleveland Arms Apts., Westgate Apts., Sable Palms Apts., Southgate Shopping Center, and Beney Road Plaza).

advised Cleveland Arms Apts. pay \$40/ hour and the other locations pay \$30/ hour. advised the officers know that they are supposed to be present at the sites for the hours they are scheduled and for the hours they report they worked. advised neither he, nor anyone with the company, have advised the officers that they can be paid for hours they were not present at the sites. When the officers work, the officers complete a log and then send the log to the company and to That log reports the number of hours the officer worked. Provided contact information for his contact with the company. The various properties are owned individually and are operated and managed by Demco Management Inc.

04-05-2016/0950 hours:

I conducted an interview of Lieutenant M. Bowen at the Integrity Unit office.

Bowen is the assigned scheduler for off duty officers at the various locations owned by Vestcor (Gregory Cove Apts. and Lindsey Terrace Apts.) as well as for Spyglass Apartments. Bowen advised the companies pay \$35/ hour to the officers for the hours they work. Bowen advised the officers know they are supposed to be present at the site for the hours they are scheduled and for the hours they report they worked. Bowen advised neither he, nor anyone with the company, have advised the officers that they can be paid for hours they were not present at the sites. Bowen advised when the officers work, the officers send him a log of the hours they worked and he forwards that to the company so the officers can get paid. Bowen provided contact information for his contact with the company. The properties are individually owned and are operated and managed by WRH Realty, Inc.

#### 04-06-2016/0635 hours:

Lieutenant Bowen forwarded me copies of the invoices Boyd submitted for working for Vestcor on the dates mentioned previously. The invoices are consistent with the above mentioned dates and times Boyd reported he worked at the companies operated and managed by WRH Realty, Inc.

#### 04-06-2016/0804 hours:

Sergeant D. Anderson (JSO Secondary Employment Office) verified that Boyd completed his secondary employment verification for dates Boyd reported he worked in February and March. Boyd submitted the verification for dates worked in February on 03-01-16 at 1752 hours. Boyd submitted the verification for dates worked in March on 04-02-16 at 1512 hours. The secondary employment verification lists the locations, dates, times and number of hours an officer works during the month. The verification states "I certify this Job History is complete, true and correct.

Sign and Date on Line Below:" The officer then electronically submits the verification to verify the information is complete, true and accurate. JSO secondary employment records, to include the verification, are public records.

Note: The various companies that employ JSO off duty officers are additionally billed \$5 for every hour an officer reports they work off duty for a company.

#### 04-06-2016/0900:

FSS 119.

I met with Barbara Aspinwall at her office located at 1515 Atlantic Blvd. Aspinwall is a Director that is employed by Demco Management Inc. and is point of contact for the locations he schedules off duty officers at. Aspinwall advised each of the properties that her company operates and manages are independently owned. Each property has a budget that the officers are paid out of. Aspinwall said the officers send her an invoice each time they work and she forwards the invoice on to make sure the officer gets paid. Aspinwall stated her company, as well as the individual properties, expect the officers to be present for the amount of hours they put on their invoices. Aspinwall said she has never given permission to anyone to allow an officer to not be present at the sites and still get paid. Aspinwall agreed to provide the invoices and copy of the corresponding checks for the dates mentioned above when Boyd reported he was present but wasn't.

Note: The total loss to the companies operated and managed by Demco Management Inc. is \$271.80.

04-07-2016/0900 hours:

I met with Barbara Aspinwall and obtained a copy of the checks and invoices issued to Boyd for the dates mentioned above. The checks for Boyd working the Southgate Shopping Center on 02-26-16 and for Boyd working the Beney Road Plaza on 3-22-16 and 3-25-16 were missing. Aspinwall advised she will locate those and provide them to me.

#### 04-08-2016/0915 hours:

I met with Cynthia Haines at her office located at 3030 Hartley Road, suite 320. Haines is the Chief Operating Officer for WRH Realty, Inc. and is Bowen's point of contact for the company. WRH Realty, Inc. operates and manages the properties owned by Vestcor. Haines advised each of the properties that her company operates and manages are independently owned. Each property has a budget that the officers are paid out of. Haines said the officers send Bowen an invoice each time they work and Bowen forwards the invoices on to make sure the officer gets paid. Haines stated her company, as well as the individual properties, expect the officers to be present for the amount of hours they put on their invoices. Haines said she has never given permission to anyone to allow an officer to not be present at the sites and still get paid. Haines agreed to provide the copies of the checks for the dates mentioned earlier when Boyd reported he was present but wasn't.

Note: The total loss to the companies operated and managed by WRH Realty, Inc. is \$540.75.

I further spoke with Gina Lee who was previously the manager of the Lindsey Terrace Apartments. Lee advised she dealt with Bowen directly when she was in that position and advised she never gave permission to Bowen, or any officer, for an officer to be able to get paid for time they were not present at that site.

#### 04-08-2016/1121 hours:

Barbara Aspinwall confirmed that Boyd has cashed all the checks issued to him for working the previously mentioned dates for her company.

#### 04-08-2016/1215 hours:

Cynthia Haines emailed me copies of the cancelled checks that Boyd received from her company for the dates he reported he worked there that are reported previously.

#### 04-13-2016/0915 hours:

Boyd arrived at the Integrity Unit office but invoked prior to being interviewed.

#### 04-13-2016/1100 hours:

Judge J. Guy reviewed and signed an arrest warrant for Boyd. The warrant was for the offenses of Official Misconduct, Grand Theft, and Petit Theft. The theft charges are for the loss of monies the various companies paid to Boyd for time he was not present at the job sites when he reported he was present. The warrant included the above mentioned dates from, and including, 02-13-2016 through, and including, 03-31-2016. The official misconduct is from Boyd falsifying the secondary employment records for reporting he worked the hours that he was not present. Secondary employment records are public records.

#### 04-14-2016/0930 hours:

Boyd arrived at the Integrity Unit office where he was arrested and transported to the PDF.

#### CASE STATUS

#### Case cleared by arrest

Affidavit for Arrest Warrant (CCR #2016-0233237). The following information was contained in the affidavit (verbatim) authored by ISIU Detective

"On 02-11-2016, your affiant was assigned to conduct an investigation of the defendant, who is a certified and sworn law enforcement officer employed by the Jacksonville Sheriff's Office.

During the course of the investigation, it was discovered the defendant worked secondary employment jobs at several apartment communities and shopping centers providing security as a police officer. During the course of the investigation, it was determined the defendant was consistently late to the job sites and/ or the defendant would leave the job sites early. However, the defendant reported to the companies and the Jacksonville Sheriff's Office that he was present at the sites his entire shift. The following is a break down of the dates and hours the defendant was not present when he reported he was:

On 02-26-16, 02-27-16, 02-28-16, 03-08-16, 03-22-16, and 03-25-16, the defendant worked secondary employment at various apartment communities and shopping center complexes that are operated and managed by Demco Management Inc. Each of the properties are independently owned. The defendant was hired to provide security at those locations and was supposed to be present his entire shift. The defendant reported to the companies and the Jacksonville Sheriff's Office that he was present at the sites for a total of 41 hours. The investigation revealed the defendant was actually only present for 32.98 of those hours. For reporting he was present for the entire 41 hours, the defendant was paid a total of \$1410.00. The defendant should

have only been paid a total of \$1138.20. The total loss to the companies operated and managed by Demco Management Inc, is \$271.80.

On 02-13-16, 02-22-16, 03-11-16, 03-12-16, 03-24-16, 03-25-16, and 03-31-16, the defendant worked secondary employment at various apartment communities that are operated and managed by WRH Realty, Inc. Each of the properties are independently owned. The defendant was hired to provide security at those locations and was supposed to be present his entire shift. The defendant reported to the companies and the Jacksonville Sheriff's Office that he was present at the sites for a total of 28 hours. The investigation revealed the defendant was actually only present for 12.55 of those hours. For reporting he was present for the entire 28 hours, the defendant was paid a total of \$980.00. The defendant should have only been paid a total of \$439.25. The total loss to the companies operated and managed by WRH Realty, Inc., is \$540.75.

The investigation also revealed the defendant repeated this pattern at other secondary employment sites. On 02-28-16, the defendant reported he was present at Spyglass Apartments working as security for 5 hours but was actually only present for 3.25 hours. Also on 03-26-16 and 03-31-16, the defendant reported he was present at Queen's Harbour Yacht Club as security for a total of 13 hours but was actually only present for 9.08 hours.

On each of the days listed above, the defendant entered his secondary employment working hours into the Jacksonville Sheriff's Office Secondary Employment website attesting that he worked the hours he reported on each of those days. On 03-01-2016, the defendant completed the Jacksonville Sheriff's Office Secondary Employment monthly verification, certifying that he worked the hours that he previously entered for the listed days in February 2016. Also, on 04-02-2016, the defendant completed the Jacksonville

Sheriff's Office Secondary Employment monthly verification, certifying that he worked the hours that he previously entered for the listed days in March 2016. The defendant was not present and working the hours he reported on those days. Jacksonville Sheriff's Office secondary employment records are official public records."

- ISIU case file for ISIU case #2016-11, which included the following:
  - o Photo spread containing the signature of on a photograph of Boyd, dated January 27, 2016, and identifying the photograph as Boyd
  - Three (3) Subpoena Duces Tecum dated February 10, 2016, requesting cellular telephone records from AT&T Wireless and Cellco / Verizon Wireless;
  - Arrest and Booking Report (CCR #2016-0233237) for Boyd's arrest;
  - Secondary Employment Records of the Jacksonville Sheriff's Office documenting the Employee Monthly Job History for ID #7766 (Boyd) for the months of February 2016 and March 2016 and emailed monthly validation with confirmation number:
  - Boyd's Secondary Employment Records from Demetree Brothers, including work history and payment;
  - Boyd's Secondary Employment Records from WRH Realty, including work history and payment;

  - DVD containing interview of Jacksonville Sheriff's Office Sworn Bailiff Lieutenant Mark E. Bowen #5520 reference Boyd's off duty employment, which was consistent with the information detailed in the Supplement Report #1 for CCR #2016-233237;
  - DVD containing interview of Jacksonville Sheriff's Office Police Sergeant
     which was consistent with the information detailed in the Supplement Report #1 for CCR #2016-233237.

#### CONCLUSION

During the course of an unrelated human trafficking investigation, the Jacksonville Sheriff's Office Integrity / Special Investigations Unit (ISIU) uncovered information regarding illegal sexual activity between known prostitutes and Jacksonville Sheriff's Office Police Officer Adam R. Boyd #7766 (CCR #2016-238000). During the course of the ISIU investigation, it was discovered that Boyd was having frequent consensual sexual relations for money with a known prostitute, as well as using his authority to force sexual intercourse on another known prostitute, while wearing his Jacksonville Sheriff's Office issued uniform, while armed with his Jacksonville Sheriff's Office issued frearm, and while using his Jacksonville Sheriff's Office issued patrol vehicle to travel to the location where the illegal sexual activity was occurring. It was unclear whether the incidents occurred while Boyd was serving in an on-duty capacity. ISIU exceptionally cleared the Sexual Battery Under the Color of Authority investigation, a first degree felony, based on the following from Assistant State Attorney Rich Mantei;

"...probable cause does exist to arrest Boyd for sexual battery. However, due to the likelihood of not receiving a conviction, Mantei advised his office would not issue an arrest warrant and would not seek prosecution. Mantei cited a lack of physical evidence and/ or additional witnesses as concerns for filing that charge against Boyd."

Based on the available information, Internal Affairs finds that there is a preponderance of evidence to prove that Boyd violated Florida State Statute 794.011(4)(b), and (e), (7) (Sexual Battery), to wit;

### 794.011 Sexual battery.—

(4)(b) A person 18 years of age or older who commits sexual battery upon a person 18 years of age or older without that person's consent, under any

of the circumstances listed in paragraph (e), commits a felony of the first degree, punishable as provided in s.  $\underline{775.082}$ , s.  $\underline{775.083}$ , s.  $\underline{775.084}$ , or s.  $\underline{794.0115}$ .

AND.

- (e) The following circumstances apply to paragraphs (a)-(d):
  - 7. The offender is a law enforcement officer, correctional officer, or correctional probation officer as defined in s. 943.10(1), (2), (3), (6), (7), (8), or (9), who is certified under s. 943.1395 or is an elected official exempt from such certification by virtue of s. 943.253, or any other person in a position of control or authority in a probation, community control, controlled release, detention, custodial, or similar setting, and such officer, official, or person is acting in such a manner as to lead the victim to reasonably believe that the offender is in a position of control or authority as an agent or employee of government.

Therefore, by violating the above Florida State Statutes, Boyd also violated the provisions set forth in General Order XI.18 (Code of Conduct), I. A. 2., to wit;

### General Order XI.18 (Code of Conduct)

- Obligation to Know and Abide by the Law, Regulations, Sheriff's Office Objectives and Orders.
  - A. Every officer shall know and abide by the laws of the State of Florida, the City of Jacksonville, the constitutional rights of citizens, and applicable restraints upon governmental power. The exercise of police power carries

with it the responsibility to enforce the law in a manner consistent with the State and Federal Constitutions. Improper exercise of this power erodes the foundation of government and public trust.

2. All members shall adhere to all laws; international, federal, state, and municipal.

Accordingly, Internal Affairs recommends that the charges of <u>Commission of Conduct Supporting Criminal Acts – Sexual Battery Under the Color of Authority</u> and against <u>Police Officer Adam R. Boyd #7766</u> be classified as <u>SUSTAINED</u>.

During the course of the ISIU investigation into Boyd's activities, ISIU discovered that Boyd had knowingly accepted compensation for secondary employment work he had not completed. An arrest warrant (CCR #2016-0233237 / S.A. #16-AF-021319) was issued and signed by Fourth Judicial Circuit Court Judge John I. Guy (Duval County), for Boyd's arrest for the crimes of Official Misconduct (a third degree felony), Grand Theft (a third degree felony), and Petit Theft (a first degree misdemeanor). On April 14, 2016, ISIU arrested Boyd and he was booked into the Pre-Trial Detention Facility (PDF). Boyd declined to provide a statement to ISIU.

Based on the available information, Internal Affairs finds that there is a preponderance of evidence to prove that Boyd violated Florida State Statute 838.022(1)(a), (3) (Official Misconduct) and, the theft statutes outlined in Florida State Statute 812.014(1)(a)(b) and (2)(c)(1), and Florida State Statute 812.014(1)(a)(b) and (2)(e) to wit;

### 838.022 Official misconduct.—

(1) It is unlawful for a public servant, with corrupt intent to obtain a benefit for any person or to cause harm to another, to:

- (a) Falsify, or cause another person to falsify, any official record or official document
- (3) Any person who violates this section commits a felony of the third degree, punishable as provided in s. <u>775.082</u>, s. <u>775.083</u>, or s. <u>775.084</u>.

AND,

812.014 Theft.-

- (1) A person commits theft if he or she knowingly obtains or uses, or endeavors to obtain or to use, the property of another with intent to, either temporarily or permanently:
  - (a) Deprive the other person of a right to the property or a benefit from the property.
  - (b) Appropriate the property to his or her own use or to the use of any person not entitled to the use of the property.
- (2)(c) It is grand theft of the third degree and a felony of the third degree, punishable as provided in s. <u>775.082</u>, s. <u>775.083</u>, or s. <u>775.084</u>, if the property stolen is:
  - 1. Valued at \$300 or more, but less than \$5,000

AND,

812.014 Theft.—

- (1) A person commits theft if he or she knowingly obtains or uses, or endeavors to obtain or to use, the property of another with intent to, either temporarily or permanently:
  - (a) Deprive the other person of a right to the property or a benefit from the property.
  - (b) Appropriate the property to his or her own use or to the use of any person not entitled to the use of the property.
- (2)(e) Except as provided in paragraph (d), if the property stolen is valued at \$100 or more, but less than \$300, the offender commits petit theft of the first degree, punishable as a misdemeanor of the first degree, as provided in s. <u>775.082</u> or s. <u>775.083</u>.

Therefore, by violating the above Florida State Statutes, Boyd also violated the provisions set forth in **General Order XI.18** (Code of Conduct), I. A. 2., to wit;

### General Order XI.18 (Code of Conduct)

- Obligation to Know and Abide by the Law, Regulations, Sheriff's Office Objectives and Orders.
  - A. Every officer shall know and abide by the laws of the State of Florida, the City of Jacksonville, the constitutional rights of citizens, and applicable restraints upon governmental power. The exercise of police power carries with it the responsibility to enforce the law in a manner consistent with the State and Federal Constitutions. Improper exercise of this power erodes the foundation of government and public trust.

2. All members shall adhere to all laws; international, federal, state, and municipal.

Accordingly, Internal Affairs recommends that the charges of <u>Commission of Conduct Supporting Criminal Acts – Official Misconduct</u>, <u>Commission of Conduct Supporting Criminal Acts – Grand Theft</u>, and <u>Commission of Conduct Supporting Criminal Acts – Petit Theft</u> against <u>Police Officer Adam R. Boyd #7766</u> be classified as <u>SUSTAINED</u>.


