UNSAFE STORAGE OF FIREARM

PROBABLE CAUSE

Jamie Gilt did leave a loaded firearm in a vehicle where she knew or reasonably should have known that a minor child could gain access to the firearm without said firearm being secured in a locked box or container or secured with a trigger lock resulting in a minor child gaining access to the firearm contrary to Florida Statute 790.174 (1). To wit: Jamie Gilt placed a loaded firearm under the front seat of her vehicle while driving with her minor child, L.G., seated behind her. L.G. was able to remove his restraints and retrieve the firearm which was accessible to L.G. from the backseat ultimately firing the weapon striking Jamie Gilt in the back.
