On 11/21/14, I arrested the suspect for Loitering and Prowling and Resisting an Officer without violence. CCR: 14-810023

The juvenile suspect was entered into the intake section (juvenile) of the Pre-Trial Detention Facility and the Corrections Officer "CO" D. Stevens gave the suspect verbal instructions to sit down which he did. CO Stevens asked the suspect standard intake questions about drug and alcohol consumption and if he was suicidal.

Suddenly, the suspect stood up, kicked a counter and then the electronic fingerprint machine while still handcuffed. Stevens went to gain control of the suspect by pushing him into a corner and then to the ground.

The suspect momentarily appeared to have gone conscienceless and was revived by a sternum rub. At this point, the suspect became super combative by kicking at the Correctional Officers, thrashing around and attempting to spit blood from his mouth at them. He was continually given verbal commands to "Stop resisting" and "Stop kicking" which the suspect continued to not comply.

During the struggle, CO Raymond Jensen was kicked about his right leg between his knee and ankle approximately three times by the suspect even after the suspect was given verbal command to "stop kicking". Jensen was not injured during the incident.

The PTFD Intake Sergeant and Watch Commander were summoned to the scene and took command.

Due to the suspect's extreme strength, endurance, and the potential of a medical emergency, the Jacksonville Fire/Rescue Department was summoned. The suspect was medically treated by Rescue #1 and transported to Shands.

Sgt S. Barreira was notified of the incident and responded to the P.T.D.F.

The following Officers were in the Intake area actively attempting to control the suspect during the incident: Vargas #69901, F. Jones #73871, Causey #74180, Hendrix #69035, Thigpen #67828, Baker #67593, Sgt J. Griffis 6725, and Lt. J. Verwey #7895.

Case cleared by arrest.
