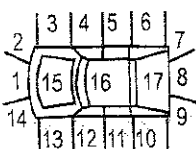

ADDITIONAL INFORMATION

On 06/21/13 at 2320, I responded to 12100 Lem Turner Rd (Walmart) in reference to a missing person. Upon arrival, I met with the complainant, [REDACTED]

The complainant stated that she met the suspect "Don" at the Dollar General at 1610 Edgewood Ave W. on 06/21/13 around 1930. The suspect initiated a conversation with the complainant by asking her if she wanted a dress. The suspect advised the complainant that his wife had a \$100 gift card for Walmart but the complainant needed to wait until she arrived to use it. The complainant waited with the suspect at Dollar General. The suspect's alleged wife did not arrive.

The suspect advised the complainant that they could meet his wife at Walmart. The complainant along with her [REDACTED] got into the suspect's vehicle and drove to Walmart at 12100 Lem Turner Rd.

The complainant, suspect and the children went into Walmart and started shopping. The suspect then walked away from the complainant and advised her that he was going to McDonalds to get something to eat. The complainant [REDACTED] (victim) followed the suspect. The suspect then exited the business and the victim followed.

The suspect and the victim then got into a white older style van. The van was last seen exiting the Walmart parking lot around 2241.

The complainant notified the police.

Investigation revealed that the complainant did not know the suspect prior to the incident. A BOLO was dispatched for the victim and the suspect's vehicle. The air unit responded and searched the area. The business supplied video surveillance of the suspect and victim leaving the store.

Lt. C. E. Ayoub (6224), Sgt. R. C Messersmith (5327), Sgt. S.C Putman (7127) and homicide Det. D.V. Alexander (5284) responded to the scene.

NCIC was contacted and dispatcher (71221) issued dispatch number (2377) at 0240 on 06/22/13.

On 6-21-2013, at 2318 hours, patrol responded to a kidnapping of [REDACTED] who was abducted from the Walmart from 12100 Lem Turner Road, Jacksonville, FL [REDACTED]. A witness [REDACTED] identified Donald James Smith as the person last seen with the victim at the Wal-Mart. Video surveillance was reviewed by detectives and showed the victim leaving the store with Donald James Smith. Donald James Smith is a registered Sexual Offender in the State of Florida.

A witness reported a tip that she possibly sighted a white van that matched the description of Donald James Smith's van parked behind a church in the 10400 block of Rutgers Road. As officers were responding to the area, they observed Donald James Smith's van driving. The van was ultimately stopped by officers and Donald James Smith was driving. There was no one else in the van. Donald James Smith was wearing the same clothes he was seen in at the Wal Mart and his clothes were soaked in what appeared to be water and were dirty.

Smith was transported to the PMB Homicide Office and read his Constitutional Rights by Sgt. D.S. Coarsey, #6957. The suspect invoked his right an attorney and the interview stopped.
