RE: Sunday May 22, 2016 JSO Ofc. Tyler Landerville shooting of 22 year old Vernell Bing, Jr.

Dear Sir/Mam:

I am interested in Justice and Truth, We hereby request a full criminal and civil rights investigation into the May 22th homicide of unarmed "Vernell Bing Jr. by Ofc. Tyler Landerville of the Jacksonville Sheriff Office (JSO). We believe the investigation will uncover that the actions of Ofc. Landerville violated both criminal law and the civil rights of Vernell Bing Jr. We also call for both independent investigation into the affairs of the Jacksonville Sheriff Office and the State Attorney's Office under directions of Angela Corey for Conspiracy under the United States Rico Act U.S. Code 18, Ch. 96 (Racketeering Influenced and Corrupt Organization Act).

A public trust in our Police Departments is a matter of the utmost importance. Every time an unarmed suspect is shot and killed by a uniform officer, it implicates the very integrity of the justice system itself. Bing was an unarmed 22 year old who was standing outside of his vehicle when he was shot at 5 times, one bullet striking him in the head, he later died at the local hospital, thus JSO Ofc. Tyler Landerville killed him in cold blood. We believe that this is a case of national interest!

The reason for this request is plain: to date the purported investigation into Bing's Homicide should be done by an independent agency (FBI). For example, we believe a Federal investigation will show the following problems surrounding Bing's homicide:

1. On May 22, 2016, Ofc. Tyler Landerville shot at Bing 5 times while unarmed, one bullet hitting him in the head, (No Weapon).
2. JSO (Jacksonville Sheriff Office, has a history of shooting unarmed black men with no officer ever being indicted.


- A. Ofc. Tyler Landerville car was crashed into by Vernell Bing Jr., but at that point Bing exited his vehicle unarmed (No Weapons), it would appear from some of the witness that Bing was appeared to be shaken up;
- B. Ofc. Tyler Landerville immediately exited his vehicle and drew his weapon shooting at Bing 5 times, hitting him once in the head.

Based on the above reference listed of concerns, we respectfully request that the U. S. Attorney's Office (Department of Justice investigate) investigate the facts and circumstances surrounding the homicide of Vernell Bing Jr., and the polices, practices and procedures of the Jacksonville Sheriff Office (JSO) and the States Attorney's Office. We are deeply troubled by the information we have learned concerning the leadership of the Jacksonville Sheriff's Office (JSO) and the State Attorney's Office.

We urge the U. S. Attorney's Office to swiftly conduct all necessary investigations. The people of Jacksonville Florida and Bing's Family and friends need the facts to restore their confidence in their safety from rouge Police forces.

We look forward to meeting with your prosecutors and FBI to discuss in detail the numerous issues surrounding the homicide of Vernell Bing Jr., We thank you in advance for your time and assistance. If you have any questions, concerns, or require more information please call.
