ADDITIONAL INFORMATION

On 01-20-17, I was working off duty at Providence School (2701 Hodges Blvd). At around 1200, Mr. Don Barfield (Head School Master/Complainant) and Dr. Tim Anderson (Upper School Principal/Witness 1) advised me that a student brought a firearm on school property. According Witness 1, a school counsellor herd of [REDACTED] (Suspect 1), bragging about having a firearm in his vehicle. After interviewing Suspect 1 (without my presence), Witness 1 and another teacher escorted the Suspect 1 back to his vehicle and verified that Suspect 1 did have a 22 calibre rifle with ammo in his truck. The rifle was secured and was hidden under the back seat of the pick up truck. Witness 1 stated that, Suspect 1 bought the rifle from Dick's and was going to use it for target shooting that weekend. Suspect 1 never told his parent's that he bought the rifle because his parent's will get upset. Both the Complainant and Witness 1 emphasized that there were no threats made by Suspect 1 to do harm or commit any violence.

Witness 1 then stated that there might be a second student involved. However, they have not located or interviewed the second student at that time. The Complainant advised me that he will immediately suspend Suspect 1. The Complainant also stated that he would make a decision as far as filing charges only after he interviews the second student and after he reviews their files.

On 01-24-17 at 1700, I contacted the Complainant to follow up on the case. The Complainant advised me that they interviewed [REDACTED] (Suspect 2) last Friday and also verified that he had a firearm in his vehicle. Witness 1 stated that Suspect 2 had a .308 calibre hunting rifle secured in a rifle case in the back seat of his pick up truck. Suspect 2 stated that he was going target shooting that weekend and had forgotten that the rifle was in his truck. However, this information was not passed on to me when I left the campus at 1600. The Complainant immediately suspended Suspect 2 as well. The Complainant stated that both students have never gotten in trouble before. The Complainant also stated that they are both good kids who made a stupid decision. The Complainant stated that he does not wish to pursue any criminal charges and have dismissed both students from Providence.

I will attempt to obtain a warrant from the State Attorney's Office.
