On 09-23-2012, I was dispatched to 3000 Mayport Road (Mayport Naval Base) in reference to assist Mayport Department of Defense Police with an assault and battery that occurred on base.

After entering the front gate of Mayport Naval Station I was flagged down by a cab driver and told the vehicle, a green Honda, that was exiting the front gate of the Naval base was being driven by the assault and battery suspect Department of Defense Police were searching for on base. I activated my emergency lights and siren and proceeded to attempt to catch up the the green Honda. I observed the green Honda southbound on Mayport Road and the vehicle turned westbound on Wonderwood Drive. I caught up to the suspect vehicle and conducted a traffic stop (CCR #699295). The vehicle stopped at Wonderwood Drive and Regas Drive East. I approached the vehicle and made contact with the driver. I observed the driver's shirt was torn and he had an abrasion on his right hand. I requested the driver to turn off the vehicle and exit the vehicle. The driver complied with my request. As I explained to the driver that he was being detained, the driver yelled, "My life is over." The driver turned and attempted to walk away. I physically detained the driver placing handcuffs on him and reading him his Miranda warning. Once again, after the handcuffs were placed on the subject he attempted to pull way.

I placed the suspect in the back of my patrol vehicle and telephoned Mayport Naval Station police to obtain further details of the incident. I spoke to Duty Officer MA1 D.L. Cregeen, who explained the subject I had detained is possibly the suspect in a battery to a cab driver on base. The cab driver (victim) was being transported to Beaches Baptist Medical Center by Mayport Naval Station Fire Rescue.

Post Miranda, as the suspect was seated in my police vehicle without questioning, he stated, "I beat the shit out of that cab driver and I'll tell you why, he said, I owed him (\$162.00) one hundred sixty two dollars. I beat the shit out of him. He disrespected me!"

As the Rescue Unit was transporting the victim to the hospital they stopped and the victim positively identified the suspect I had detained as the subject who attacked him and refused to pay for his cab fare of \$44.00.
