Before me the undersigned Fourth Circuit Judicial Officer, in and for Duval County, notary public, or law enforcement officer personally came M J SOEHLIG, who, being duly sworn deposes and says that he/she has reason to believe and does believe that one **Summer Brooke Wilbanks**, described as follows: Last known address: 2014 Joann RD, Pulaski, TN 38478; Race: **WHITE**; Sex: **FEMALE**; DOB: 10/18/1991; Ht: 5' 06"; Wt: 180; Hair: **BROWN**; Eyes: **BLUE**; Scars, Marks: ; did in Duval County, Florida, on April 20, 2017, commit the below listed offense(s), contrary to the provisions of Florida Statutes:

- 1) 782.04(4), MURDER IN THE THIRD DEGREE; F2

Affiant's reasons for so believing are as follows:

On 04-20-2017, Eric White was shot and killed while seated in the front passenger seat of his vehicle (Toyota Camry), near the 5600 block of Amazon Avenue. The victim's girlfriend, Summer Wilbanks, was seated in the front driver seat of that vehicle. She, however, was not injured in the shooting. Summer stated earlier in the evening on 04-19-17, she and Eric agreed to meet up with a friend of Eric's from jail, "Bird" (later identified as Breon Hollings) to purchase illegal narcotics. She said Eric and "Bird" spoke on the phone and through text messaging about the narcotics purchase. Summer explained that Eric arranged to meet up with "Bird" to pay him with \$600.00 cash and Ecstasy pills in exchange for 50 Roxy pills. Summer relayed that she and Eric purchased caffeine pills from Walmart to imitate real Ecstasy pills and purchased "imitation/fake" currency which was rolled up to look like real money. Summer explained that Eric planned on making the drug purchase and exchange quickly before "Bird" realized the money and Ecstasy pills were counterfeit. Summer was fully aware of the exchange of the imitation money and imitation Ecstasy pills for the 50 Roxy pills and agreed to participate by driving Eric to the location in hopes to obtain the real drugs for personal use. Summer explained that "Bird" sent a text message to Eric relaying to meet him at 5675 Amazon Ave. Once she and Eric arrived near the 5600 block of Amazon Avenue to make the narcotics transaction, she observed four (4) black males approach her vehicle on foot; one (1) male as "Bird" (Breon Hollings) approached the passenger side where Eric was sitting and one (1) male pulled open her driver-side door and placed a gun to her head. Summer stated when Eric yelled and told her to drive away, then one of the men began shooting into the vehicle.

On 04-20-17, Dr. Rao from the Medical Examiner's Office ruled Eric White's death as a homicide by penetrating gunshot wound to the chest.
