Background and Investigation:

On Friday, May 5, 2017, Investigator Gregory was notified by Sergeant Kenny Brooke, Duval County School Police (DCSP), of an incident that occurred on May 2, 2017, at Lake Shore Middle School. Sgt. Brooke provided a copy of the General Offense Report (**Attachment 2**). The report stated a class had taken a field trip for part of the day on Tuesday, May 2, 2017. Upon returning to school, some of the students were in Mr. Brent Sawdy's class. According to the complaint, several of the students began playing a game of Truth or Dare. At some point two of the girls involved allegedly exposed their breasts, and one of the boys licked or kissed one of the girls' breast. Investigator Gregory contacted Principal Caleb Gottberg at Lake Shore Middle. Mr. Gottberg provided notes (**Attachment 3**) he took when he spoke with the complainant, ██████████ as well as a classroom map (**Attachment 4**) that she drew. He later provided a Misconduct Reporting Form (**Attachment 1**).

Investigator Gregory responded to Lake Shore Middle School where he spoke with Judy Edwards, school secretary. Ms. Edwards was approached Wednesday morning by ██████████ parents. They were not upset, but concerned about behavior ██████████ observed in Mr. Sawdy's class. Ms. Edwards spoke to ██████████ who relayed what she saw in the class. Because it was the beginning of the day, prior to the start of school, Ms. Edwards completed her morning duties. Immediately after announcements, she told Mr. Gottberg what she had been told.

Investigator Gregory spoke with Ofc. M. Knouse, Duval County School Police. Ofc. Knouse was told of the allegations by Principal Gottberg and spoke with ██████████ repeated her observations to Ofc. Knouse. Ofc. Knouse spoke with ██████████ ██████████ heard a group say they were going to play dirty dare. He also saw ██████████ and ██████████ kiss. The other students Ofc. Knouse spoke with said they did not observe anything in the classroom.

Investigator Gregory conducted the following interviews while at Lake Shore Middle School:

██████████

They took a field trip to Diamond D Ranch. Upon returning he was in Mr. Sawdy's class. When the students first entered the classroom Mr. Sawdy joked about the students having to take a test. He stated he had work to do and as long as the students "were chillin'", he would get some work done. Initially Mr. Sawdy put some music on. Eventually other students started selecting the music. ██████████ was sitting near the door. Mr. Sawdy was sitting at his desk and going back and forth to the cabinet. The lights were off but there was natural lighting coming from the windows.

All the students were bored and somebody suggested playing Truth or Dare. ██████████ dared ██████████ to lick the floor, but he wouldn't do it. He dared other people. He was dared to lick the dry erase board, so he did it. He didn't kiss anyone or anything like that. He did sniff the inside of his own shoe. He walked to the board, licked it, and as he walked back, it appeared that ██████████ flashed ██████████ but he didn't actually see it.

██████████

After returning from the field trip he ate lunch before going to Mr. Sawdy's class. Mr. Sawdy first joked about giving them a test. Then he said they had free time to work on note cards. He started playing Bill Nye, and was going to play Hamilton. Nobody was paying attention so Mr. Sawdy told them to keep the noise down because he had work to do.

██████████ sat by ██████████ and they were on her phone. Their friends gathered chairs around the closest tables and desks. It was ██████████. At first they were all on their phones but they got bored. He and ██████████ were closer to the corner, talking on Instagram Live with ██████████. ██████████ tried to smack ██████████ on the butt but hit her thigh instead. Mr. Sawdy saw what happened and took ██████████ out of the class for a minute. He supposedly warned him. ██████████ was trying to get him to play by pulling on his shirt. She said very loudly that anybody that has a girlfriend needs to go to the other side of the room. He had gone to the other side of the class because he does have a girlfriend, but walked back to retrieve his backpack. When he walked back he saw ██████████ pull her shirt up and her bra down, fully showing her chest to the group. She had her back to the classroom so he doesn't think anybody else saw the actions.

After ██████████ exposed her breasts, ██████████ pulled both her shirt and bra up and exposed her breasts. Everybody at the table and desks made a sound like, "ewwww." Many of the other students in class asked what happened. Some students acknowledged that ██████████ "flashed." Mr. Sawdy was at his desk looking down. He appeared to have heard the noise and looked up. The students' answer about what had happened was quieter and it is not likely that Mr. Sawdy heard that. ██████████ was dared to lick ██████████ chest and ██████████ saw him do it. ██████████ and ██████████ were flashed by both ██████████ did not see anybody else "flash."

The next day Mr. Sawdy called several of the students into the media center and asked about what happened the previous day in class. He had been made aware of a complaint. Nobody admitted what happened to Mr. Sawdy. As he walked into the media center, ██████████ was walking out. She told him not to snitch, and he thinks Mr. Sawdy heard her say it.

She went on the field trip to Diamond D Ranch. After returning she went to third period, had lunch, and went to Mr. Sawdy's class. When the class first entered Mr. Sawdy's room, [REDACTED] seemed upset and kissed [REDACTED]. Mr. Sawdy first joked about the students having a test. He put a movie on the projector but nobody was watching it. Mr. Sawdy eventually just put on music. Some of the other kids including [REDACTED] and [REDACTED] went to the other side of the room in a group. [REDACTED] was over there but wasn't doing anything. [REDACTED] heard somebody say, "Let's play Dirty Dare". Before they started playing the game, [REDACTED] said out loud that if anyone had a girlfriend, they needed to go to the other side of the class.

The first thing she observed was [REDACTED] "twirking" on [REDACTED]. She was standing up and he was sitting. [REDACTED] went to the board and [REDACTED] was on the other side of her. It appeared [REDACTED] did something but [REDACTED] could not tell what. At one point [REDACTED] observed [REDACTED] and [REDACTED] rub on [REDACTED] groin area. [REDACTED] lifted her shirt and "flashed" the group that was in the corner. [REDACTED] may have seen it but [REDACTED] is not sure. [REDACTED] lifted her shirt and bra and flashed the group as well. Nobody touched her. At one point, [REDACTED] grabbed [REDACTED] inner thigh. She only laughed. Right before [REDACTED] walked out of the classroom, she saw [REDACTED] lift her shirt, pull her bra over to expose one breast, and [REDACTED] licked her breast. Mr. Sawdy was at his desk the entire time, working on his computer. [REDACTED] does not recall Mr. Sawdy ever getting up from his desk. She did not notice Mr. Sawdy say anything to anybody, or take anybody out of the class. He got up from his desk at about the time the car riders were leaving. The next day Mr. Sawdy called some of the students involved into the media center. She was not one of them called.

On May 8, 2017, Investigator Gregory responded to Lake Shore Middle School and conducted the following interviews:

When she first went into Mr. Sawdy's class he asked if the class wanted some free time. He told them not to be too loud and they could work on other school work. Mr. Sawdy sat at his desk and worked on his computer. He played some music through the class system. The lights were off when they came in. There is ambient lighting. Although there is normally assigned seating, everybody sat where they wanted to that day. She sat at a desk near the door, and [REDACTED] came, pulled up a chair, and sat beside her. [REDACTED] and [REDACTED] came over close and gathered their chairs around some other desks. She went on Instagram Live with [REDACTED]. The group started playing Truth or Dare. She saw [REDACTED] lick a chair, and others licked the table and somebody's socks.

█████ didn't participate in any of the dares. She had gotten up and walked around the class some, talking to other students. She heard them talking about kissing but she never observed any. She did hear █████ tell everybody who had a girlfriend to go to the other side of the classroom. █████ claimed that the entire group moved at one point. She didn't see anybody kiss, nor did she see any of the girls expose their breasts.

██████████

██████████ was in In-School Suspension when she was called for this interview. Both she and ██████████ got in trouble for fighting with other students. ██████████ did not go on the field trip. After lunch she went to the bathroom before going into Mr. Sawdy's classroom. She heard him say that he would give them free time. They normally have assigned seats but they weren't required to sit in them that day. ██████████ were at a desk near the corner. Then ██████████ and ██████████ were all grouped together. They are all friends, but not boyfriend and girlfriends.

██████████ said she wanted to play dirty dare. She doesn't think ██████████ said it loud enough for Mr. Sawdy to hear. ██████████ wasn't participating. ██████████ was the one who really wanted to play. She was dared to lick ██████████ socks but refused to do it. ██████████ was dared to slap ██████████ on the bottom but when he swung, he struck her more on the thigh. ██████████ was laughing but Mr. Sawdy saw it happen and said something to ██████████ and ██████████ went to where the music was playing because the song from Frozen was on. They joined in singing to it before returning to the group and playing the game. ██████████ sat on her lap on a dare and kissed her cheek. ██████████ slapped ██████████ butt. ██████████ did flash ██████████ ██████████ moved so she isn't sure if ██████████ saw it. Somebody dared ██████████ to kiss ██████████ but he didn't. ██████████ saw ██████████ lift her shirt in front of ██████████ but she didn't see him lick her. ██████████ saw it. ██████████ also tried to touch ██████████ groin area but he turned away. At one point ██████████ sat in all of the boys' laps.

██████████ never touched any boys' groin area. She didn't flash anybody. She never lifted her shirt. She was dared to kiss ██████████ but she didn't do it. She didn't kiss anybody and didn't see anybody else kiss. She was not one that Mr. Sawdy spoke to the day after the incident. She did hear that ██████████ yelled for them not to snitch.

██████████

Mr. Sawdy said he would play a video and they could do their study cards and talk quietly. He played a game on his phone. Then he went and sat by ██████████. ██████████ Mr. Sawdy was at his desk doing work. They decided to play Truth or Dare. He was dared to hug his ex-girlfriend for 10 seconds and did. ██████████ was dared to kiss ██████████ but she had gone to the bathroom. By the time ██████████ returned, he had forgotten because there were other dares. He was dared to kiss ██████████ on the lips and they did. ██████████ was dared to kiss ██████████ but he didn't see whether he did it or not. ██████████ slapped ██████████ butt. Mr. Sawdy saw that and took ██████████ out of the classroom and spoke to him.

At one point ██████████ flashed them but all he saw was her bra. Somebody dared him to lick ██████████ chest. She lifted her shirt and pulled her bra part way over and he licked her. It was high on her chest, just over the bra. ██████████ sat in ██████████ lap but he tried pushing her off. He saw ██████████ and ██████████ kiss but heard ██████████ kissed them as well. He never saw the girls touch the boys in the crotch. ██████████ tried to touch him as he went by but missed. Other than kissing he heard that ██████████ just watched.

██████████

When they entered Mr. Sawdy's class he told them they were going to have free time. The lights were already off when they came in the room. They frequently are because there is

sufficient ambient lighting. She sat in her normal seat and the rest of the group gathered around her. She considers them her friends. She sat down and [REDACTED] sat with her. Then the others came around. They pulled up chairs around the desks. They were bored and wanted to play Truth or Dare. They started with dumb stuff. First they dared [REDACTED] to sit in [REDACTED] lap and kiss her cheek, which she did. She doesn't remember any others kissing. [REDACTED] and [REDACTED] were over in the corner by themselves.

[REDACTED] was dared and tried to slap her bottom but actually hit her inner thigh. She didn't get upset but Mr. Sawdy saw it happen. He pulled [REDACTED] out of the class and warned him about his actions. She heard that [REDACTED] was dared to kiss [REDACTED] but she didn't see it happen. She never saw the boys touch the girls. [REDACTED] did flash the group and they all went "ewwww." With the direction [REDACTED] was facing, [REDACTED] doesn't think anybody other than the group would have seen it. After that [REDACTED] pulled her shirt down, and her bra over, and [REDACTED] licked her chest. She thinks [REDACTED] claimed that one of the girls touched him but she didn't see it. Mr. Sawdy kept telling them to keep it down but didn't actually do anything. [REDACTED] did flash the group once as well.

The following day she was called out of class by Mr. Sawdy. He didn't ask any details about what happened but asked if it was appropriate for school.

On Thursday May 25, 2017, Investigator Gregory conducted an interview with Brent Sawdy at the Office of Professional Standards (OPS). Supervisor Broderick Edwards was present.

Brent Sawdy

Mr. Sawdy was reminded of his right to have representation and declined. He went on a field trip on May 2, 2017. It was a 7th grade trip and he went with 4 other teachers. He thinks that about 20-30 7th graders stayed behind, either because of grades or by choice. After returning to campus there was a 15-30 minute break before 4th period started. When his students entered the class he informed them that they would have an independent study period. He was putting on a video of Bill Nye the Science Guy. They had the option to listen to music quietly on their headphones. The overhead lights were left off but he always leaves them off. There is enough ambient lighting from outside, and he thinks it maintains a calmer learning environment. While the students studied he worked at his desk, periodically walking around the classroom.

At one point during study time he saw a male student play slap a girl's leg. He led that student to the door and explained that although he appeared to be playing, that kind of playing could get him in trouble.

Mr. Sawdy realized that nobody was paying attention to the video he was playing so he played music on the overhead system. He never heard anyone say anything about playing a game. He never heard anyone say anything about Truth or Dare. He did not hear or see any students do anything else questionable.

Mr. Sawdy said that although he did not see or hear any inappropriate actions during class, the reason he asked the students that he did about their actions, is he assumed they are the students that would have done something. After he was made aware of the allegations, Mr. Sawdy thought he could help by asking questions. He was not told at that time that an investigation was being initiated. He called several students out of their classes during his planning period to ask about their actions in his class. They all denied anything had happened,

and [REDACTED] told him he was crazy. He never heard a student tell another student not to "snitch".

On August 15, 2017, Investigator Gregory spoke with Marissa Gagnon, Child Protection Investigator with the Department of Children and Families (DCF). Ms. Gagnon advised she closed the investigation as substantiated for inadequate supervision. Her findings are directly linked to the fact students were able to play "Dirty Dare" while Mr. Sawdy was in the room.

Past Investigations and/or Disciplinary Actions:

Mr. Sawdy has not been the subject of a prior investigation by the Office of Equity and Inclusion/Professional Standards.

Conclusion:

Mr. Sawdy violated the Principles of Professional Conduct of the Education Profession in Florida (Florida Administrative Code 6A-10.081).

Specifically, the following Principles of Professional were violated:

6A-10.081(1)(a) – The educator values the worth and dignity of every person, the pursuit of truth, devotion to excellence, acquisition of knowledge, and the nurture of democratic citizenship. Essential to the achievement of these standards are the freedom to learn and to teach and the guarantee of equal opportunity for all.

6A-10.081(1)(b) –The educator's primary professional concern will always be for the student and for the development of the student's potential. The educator will therefore strive for professional growth and will seek to exercise the best professional judgment and integrity.

Based upon the foregoing, it was determined there is a preponderance of evidence to support the allegations that Mr. Sawdy failed to provide adequate supervision when he allowed students in his class to participate in an inappropriate game which involved kissing and exposure of private parts.

On 5/4/2017 at 1000 hours, while working as School Resource Officer at Lake Shore Middle, Judy Edwards (complainant/Principal's Secretary) advised that she meet with [REDACTED] (parents of [REDACTED] witness 1). The complainant (Edwards) advised that they expressed concerns about inappropriate behavior in a classroom that occurred on Tuesday 5/2/2017.

On 5/4/2017 I spoke with [REDACTED] (witness 1) and she advised that on Tuesday 5/2/2017 her grade level went on a field trip. When they returned to school they reported to their fourth period class. She advised that her teacher, Brent Sawdy told the class that they could work on school work or talk with their friends. Witness 1 [REDACTED] advised that the lights in the classroom were turned off and that the teacher (Sawdy) had music playing. Witness 1 [REDACTED] advised that she sat on a table in the back of the class facing a group of kids. Witness 1 [REDACTED] advised that she heard this group say they were going to play a game called "dirty dare." Witness 1 [REDACTED] advised that the group started the game by daring each other to kiss one another. Witness 1 [REDACTED] advised that girls were kissing girls and girls were kissing boys at this point. Witness 1 [REDACTED] advised she then observed [REDACTED] (witness 7) and [REDACTED] (witness 9) both lift their shirts above their breast and then pull up their bras fully exposing both breast. Witness 1 [REDACTED] advised that witness 7 [REDACTED] then unbuttoned her shirt and exposed her left breast in her bra. Witness 1 [REDACTED] advised that witness 7 [REDACTED] then pulled her bra to the left side fully exposing her left breast and at that point [REDACTED] (witness 6) leaned over and licked the exposed breast. Witness 1 [REDACTED] advised next she observed witness 7, [REDACTED] witness 9, [REDACTED] and [REDACTED] (witness 5) begin taking turns rubbing witness 6 [REDACTED] [REDACTED] (witness 8) and [REDACTED] (witness 4) in their crotch area over clothing. Lastly witness 1 [REDACTED]

advised that [REDACTED] (witness 3) approached her and told her that he was dared to kiss her. Witness 1 [REDACTED] advised that she kicked at witness 3 [REDACTED] and that he then walked away.

I had witness 1 [REDACTED] draw a diagram of the classroom and then we went over where students were sitting in the class. From the diagram I spoke with multiple students who may have witnessed the game being played. [REDACTED] (witness 2) advised that he heard the group say that they were going to play "dirty dare." Witness 2 [REDACTED] further advised that he observed witness 7 [REDACTED] and witness 6 [REDACTED] kissing each other. All other students questioned advised they did not observe anything in the classroom on 5/2/2017.

Caleb Gottberg (Principal) spoke with Brent Sawdy (teacher) about this incident and he advised that he did not observe any of the above listed behavior's in the classroom.

The school will also be handling the discipline of the students involved in this incident.

I spoke with Detective T. Golden #51885 of the Duval County School Police regarding this incident.
