Before me the undersigned Fourth Circuit Judicial Officer, in and for Duval County; notary public; or law enforcement officer personally came N S CHANDLER, who, being duly sworn deposes and says that he/she has reason to believe and does believe that one **LOGAN TYLER MOTT**, described as follows: Last known address: [REDACTED]; Race: **WHITE**; Sex: **MALE**; DOB: **08/21/2002**; Ht: **5' 09"**; Wt: **140**; Hair: **BROWN**; Eyes: **BROWN**; Scars, Marks: ; did in Duval County, Florida, between **November 20, 2017** and **November 22, 2017**, commit the below listed offense(s), contrary to the provisions of Florida Statutes:

1) 782.04, MURDER LI

Affiant's reasons for so believing are as follows:

Your Affiant has been employed with the Jacksonville Sheriff's Office for more than 13 years and is currently assigned to the Homicide Unit.

Your affiant, Detective N.S. Chandler (60858), was assigned to investigate death of Kristina French on 11-22-17 at [REDACTED]. The victim (Kristina French) was found deceased in a shallow grave in the backyard of the residence. The victim's death was ruled a homicide.

The initial investigation has revealed that Eric Mott, the son of the victim (Kristina French) and father of 15 year old suspect, Logan Mott, was on vacation before the reported incident and left the suspect (Logan Mott) in the care and custody of the victim. Eric Mott flew back into the Jacksonville area on 11-22-17 and was not met by the victim or his son (suspect) at the airport; as was planned prior to his departure. Eric Mott attempted to contact the victim (via phone), but was unable to get her to answer the phone. After making alternative transportation methods and returning home to his residence at [REDACTED], he discovered the home to be unsecured and in disarray. Eric Mott discovered the victim's vehicle, several firearms and pain medicines were also missing.

Further investigation revealed the victim failed to show up for work that week while the suspect (Logan Mott) failed to arrive at school.

On 11-22-17, a Search Warrant was obtained for Eric Mott's residence at [REDACTED]

On 11-23-17, the victim's debit card was used at an ATM in Pennsylvania. Video surveillance at the location showed a male appearing to be the suspect (Logan Mott) using the ATM and a vehicle matching the victim's car leaving the area.

On 11-24-17, the processing of the residence and the backyard of the residence revealed the location of the victim (Kristina French); deceased in a shallow grave. Based on the evidence gathered during the investigation at this point, an Auto Theft warrant was obtained for the suspect's (Logan Mott) arrest.

On 11-24-17, the suspect was detained by United States Border Patrol Agents in Buffalo, New York. The suspect was in possession of the victim's vehicle and firearms reported stolen from his residence.

On 11-25-17, an autopsy was performed by the District IV Medical Examiner's Office. It was reported the victim died as a result of a gunshot wound. The manner of death was ruled a Homicide.
