Before me the undersigned Fourth Circuit Judicial Officer, in and for Duval County; notary public; or law enforcement officer personally came D M GRAY, who, being duly sworn deposes and says that he/she has reason to believe and does believe that one **Logan Tyler Mott**, described as follows: Last known address: [REDACTED] Race: **WHITE**; Sex: **MALE**; DOB: **08/21/2002**; Ht: **5' 09"**; Wt: **160**; Hair: **BROWN**; Eyes: **BROWN**; Scars, Marks: ; did in Duval County, Florida, on **November 22, 2017**, commit the below listed offense(s), contrary to the provisions of Florida Statutes:

- 1) 812.014(2)(c)6, GRAND THEFT AUTO; F3

Affiant's reasons for so believing are as follows:

On 11-22-2017, officers responded to [REDACTED], in Duval County, Florida in reference to a missing person incident with the possibility of foul play.

The initial investigation has revealed the Eric Mott travelled out of the country approximately ten days ago leaving his fifteen year old son, Logan Mott, in the care and custody of his grandmother, Kristina French. Mr. Mott arranged to be picked up at the airport on 11-22-2017 by his mother, Kristina French. He flew in on 11-22-2017 and was not met by his Kristina French or his son, Logan Mott. Mr. Mott attempted to make contact with his mother, Kristina French, but was unable to get anyone to answer. Mr. Mott then made alternative transportation arrangements and returned home to his residence at [REDACTED]. He arrived and entered into his home and found the home to be unsecure and in disarray. He then left his residence and went to his mother's residence located at 1264 South Nipigon Avenue. He was unable to locate his mother or his son and the mother's Silver Dodge Dart with Florida tag DLLT42 and VIN # 1C3CDFDH1FD146613 was missing. When Mr. Mott returned to his home, he discovered his safe had been damaged and three guns and pain medicines had been taken. Law enforcement was contacted and responded to [REDACTED] and 1264 South Nipigon Avenue.

Further investigation revealed Kristina French failed to show up for work 11-20, 11-21 and 11-22 and Logan Mott was not at school on 11-20 and 11-21. The investigation has been on-going and additional information has been obtained from Eric Mott. He advised his son, Logan Mott, only has a learner's permit and is not permitted to drive any vehicles.

On 11-23-2017, at 1315 hours, the victim's debit card was used at an ATM near Hanover, Pennsylvania. Video showed a male appearing to be the suspect, Logan Mott, using the ATM and then a silver colored Dodge Dart leaving the area.

On 11-24-2017, during the processing of the residence at [REDACTED], the grandmother, Kristina French was located deceased in the backyard. Kristina French's vehicle has still not been located.
