On 04-15-18, at 0953, I was dispatched to American Legion Post #9 located at 10737 New Kings Rd. in reference to assisting JFRD on a structural fire.

State Fire Marshall J.L. Baker S224 responded, and advised that this was arson. He further advised that it was also a burglary. A few coin operated machines, and an ATM machine were broken into. It is unknown at this time how much money if any was taken.

The exterior wall is made of sheet metal, and it appears the suspect gained entry into the building by removing several screws that held the sheet metal in place. It is unknown where the suspect exited.

The complainant is the post commander. She stated the business was closed early this morning, at 0000. The complainant stated **119.071(3), F.S.**

Intelligence Detective 119.071(4)(c), F.S. was notified and stated he would follow-up with State Fire Marshall Baker.

An ET was called to process the scene.

There are no known suspect(s) or witnesses at this time.
