- 5. Defendant shall seek treatment for PTSD with the Veteran's Administration facility closest to Theodore, Alabama. Such treatment may be in-patient or out-patient as directed by the treating Physician/Psychologist.
- 6. Defendant shall authorize his treating Physician/Psychologist to make a report to the District Attorney, Glynn County, Georgia and Glynn County CSRA, every 90 days, of Defendant's progress and steps toward treatment and whether Defendant should be released from

treatment and the conditions of such release.

- 7. Defendant agrees that such information from his treating Physician/Psychologist may be used to amend this Bond Order either by agreement or after a hearing with notice to the Defendant and the opportunity to be heard.
- 8. Defendant shall give all guns and weapons to a third party, shall not possess any such weapons during the pendency of this bond Order and shall not purchase or possess any gun, whether a long gun, shotgun, or handgun.
- 9. Defendant shall report to CSRA in Glynn County every 30 days and this reporting may be by use of the CSRA app. Defendant shall report to the Veteran's Administration for treatment on or before June 1, 2018 and shall also report to CSRA upon entry into treatment and shall provide contact information for the Physician/Psychiatrist responsible for his treatment.
- 10. Defendant shall notify CSRA in Glynn County 48 hours before his return to Glynn County for any reason.
